Preface

In 2019, CIM participated in two important events with lasting impact on our work

The formation of the Amsterdam Satellite of Cochrane Work. The opening of the new Amsterdam Satellite of Cochrane Work started with a symposium of international speakers representing clinical researchers, research methodologists, systematic reviewers and review managers, guideline methodologists and guideline developers, international professional organisations and policy makers. The high-profile representation acknowledged the importance of the reviews produced by Cochrane Work for clinical guidance and policies. Why is this event important to Cochrane Insurance Medicine? Cochrane Work, the producer of systematic reviews and Cochrane Insurance Medicine disseminating evidence are close allies in their efforts to prevent work disability, to keep people with health impairments in the labour market and to strengthen efforts for rehabilitation and return to work. The funding crisis raised awareness for the need of close collaboration and strengthened the ties.

The times are changing. While cancelled last minute, the 26th Cochrane Colloquium transformed its physical format into its first truly virtual colloquium ever. In 2019, the world observed the unprecedented event that a Cochrane Colloquium had to be cancelled just two days prior to its official start on the 22nd of October. Ongoing civil unrest in the streets of Santiago, Chile, due to worsening social conditions and the shutdown of the airport made 800⁺ researchers, practitioners and patients from 56⁺ countries strand in Chile's capital or somewhere on their way to Chile. To compensate for missed opportunities and acknowledge the many contributions prepared by the participants, Cochrane turned ad hoc the physical colloquium in a <u>virtual event</u> where participants listened to e-plenaries, attended webinars, presented digital posters and communicated through twitter and Instagram. Dr. Adrian Verbel, the CIM coordinator, presented our <u>Survey on evidence needs in insurance medicine</u>. Civil unrest triggered Cochrane's creative mind to set up this ad-hoc virtual meeting for its worldwide community. It thereby directed its community to innovative opportunities of connecting in challenging times.

Prefaces are always a good place to say thank you to those who accompanied us throughout the year: our contributors, members and followers from practice, research, and policy who keep inspiring us with new ideas. We thank our colleagues and friends who offer opportunities for dissemination to make insurance medicine at all levels more evidence-based.
